6 Placing an order

- 6.1 By completing an online purchase order, you are making an offer to purchase the selected product at the price set out in our website and pursuant to this Agreement. When you place an online purchase order, you are bound by your order for a period of seven (7) days, unless we reject your order before then. You may not change or cancel an order you have already made.
- 6.2 You will initially receive an email confirming receipt of your online purchase order. This email is generated automatically and does not constitute acceptance of your order. If we accept your online purchase order, we will, within seven (7) days from our receipt of your order, send you an email confirming that we accept your order and/or providing information on the dispatch of the ordered item. A purchase contract is only concluded if and when we accept your online purchase order. If we reject your order (which we may do at our sole discretion) you will not receive an order acceptance confirmation.
- 6.3 The bill and ship to party in the online order has to be in the same country as Export Sales cases are not handled via the website.

7 Prices and payment

- 7.1 The prices for our products are the prices set out on our website valid at the time of your order and are quoted CIP Anton Paar Australia Pty. Ltd. (Incoterms 2020). Any value added taxes or other taxes or duties, insurance, freight and shipping costs for the delivery will be itemized on your respective order documents separately. Prices quoted on our website cannot be combined with offers or discounts.
- 7.2 Payment can be made in Australian dollar only. Payment shall be deemed to have been effected on the date at which the amount in question is at our disposal.
- 7.3 We accept the following payment methods:
 - a. Credit cards: Visa, MasterCard
- 7.4 If you chose to pay with your credit card, you warrant in each case that you are an authorized user of the credit card used to complete payment. You authorize us to charge your selected credit card, if we accept your purchase order. The card presented for payment must have a valid security code. 8 PPSA

8.1 In this clause:

- a) PPSA means the Personal Property Securities Act 2009 (Cth);
- b) the terms "Proceeds", Register, "Purchase Money Security Interest", "Security Agreement", "Security Interest", "Verification Statement", "Financing Statement", "Register" and "Financing Change Statement" will have the meanings given to them in the PPSA.

8.2 The Buyer:

- c) acknowledges that these Terms and each order constitutes a Security Agreement for the purpose of the PPSA;
- d) grants a Security Interest to Anton Paar in all products (and the Proceeds) previously supplied by Anton Paar to the Buyer and in all future products (and the Proceeds) supplied by Anton Paar to the Buyer; and
- e) acknowledges that the Security Interest granted in accordance with clause b) is a Security Interest for the purpose of the PPSA;
- f) acknowledges that Anton Paar may register its Security Interest in the products (and the Proceeds) as a Purchase Money Security Interest on the Register;
- g) must execute documents and do such further acts and things and provide such further information as may be required by Anton Paar to enable registration of the Security Interest granted by the Buyer on the Register, or to perfect or correct any registration;
- h) agrees that to the fullest extent permitted by law, Anton Paar owns, and the Buyer waives any rights it may have to anything installed in or affixed to the products, including any rights it might otherwise have under Part 3.3 of the PPSA;
- i) agrees that where the PPSA applies to action taken by Anton Paar in relation to the products, that sections 116(2), 120, 125, 142 and 143 of the PPSA will not apply;
- j) waives any rights to receive any notice Anton Paar is required to give to the Buyer under the PPSA (to the extent the notice can be excluded) and includes any rights to receive a notice under sections 95, 118(1)(b), 121(4), 123(2), 130, 132(3)(d), 132(4) and 135 of the PPSA and any Verification Statements.

9 Delivery and Return

- 9.1 Unless agreed otherwise, the products will be provided CIP Anton Paar Australia Pty. Ltd. (Incoterms 2020) and risk of loss of the products will pass to you upon such delivery point as defined per agreed Incoterm, whether or not the shipment is effected, organized or supervised by you or us and regardless of any installation or assembly work to be performed by us after the delivery of the products.
- 9.2 We will arrange for dispatch of the items you have ordered according to the delivery times set out in the website. We may dispatch items you have ordered in one or more parcel(s). Depending on your destination, typical delivery times are between one to ten days from dispatch. All dates and times are a mere estimate. We will inform you about the dispatch and the estimated delivery date of the item(s) by email. Unless expressly agreed otherwise, this delivery time only applies to orders in quantities corresponding to the typical needs of an average household.

- 9.3 If you are not 100 % satisfied with the online purchase of one of the products named in this paragraph, you can return the instrument within the first 30 days of usage and get a full refund excluding shipping, tax and handling charge. The 30 days period is calculated from the day, the delivery arrived at your premise. This Online Return Campaign is valid until further notice on the Anton Paar website www.anton-paar.com. Any product you return must be in the same condition you received it and has to be sent back in the original packaging. This campaign is valid for the following products:
- a. ViscoQC 100
 - b. ViscoQC 300
 - c. Monowave 50

10 Warranty and repair

- 10.1 The express warranty given under this clause 10 is subject to clauses 10.7, 10.8. and 11.2. For the period of thirty six months from the delivery, Anton Paar warrants that the delivered Instrument as defined below a) conforms to the specifications provided by Anton Paar; and b) is free from latent or patent defects in material or workmanship that impede the use of the products as specified by Anton Paar, provided all mandatory maintenance in accordance with the Instrument's manual, if any, has been performed by Anton Paar or a representative authorized in writing by Anton Paar. An Instrument ("Instrument") means an instrument and all its accessories purchased from Anton Paar. Custom tailored solutions are explicitly excluded. The warranty will immediately lapse if mandatory maintenance is not performed according to the provisions of this clause.
- 10.2 If a product is found to be defective during the warranty period, Anton Paar shall remedy such deficiency, at its option and its cost, by the repair or replacement of the defective product at the Buyer's or Anton Paar's premises or an adequate reduction in price. The warranty period for the repaired or replaced product shall run for the remainder of the initial warranty period. Any and all other costs and/or expenses, including but not limited to shipping, travel costs and accommodation costs shall be borne by the Buyer. For warranty work on the Buyer's premises, the Buyer shall make available free of charge any assistance, hoisting gear, scaffolding and sundry supplies and incidentals that may be required. Replaced parts shall become the property of Anton Paar.
- 10.3 Unless otherwise agreed in writing, any warranty by Anton Paar shall be to the Buyer only and may not be transferred or assigned to any third party.
- 10.4 To the extent permitted by law, this warranty shall be in lieu of all statutory warranty provisions. To the extent permitted by law, all other warranties or conditions (whether express or implied) as to quality, condition, description, compliance with sample or fitness for a specific purpose (whether statutory or otherwise) other than those expressly set out in these Terms are excluded.
- 10.5 Anton Paar shall not be liable for a defect in the products and/or services unless the defect is notified in writing to Anton Paar at 2 Julius Avenue, North Ryde NSW, within 10 days from the date of delivery, or if the defect would not be apparent on reasonable inspection, within the long stop warranty period of thirty-six months from the date of the delivery.
- 10.6 If a product is manufactured by Anton Paar on the basis of design data, design drawings, models or other specifications provided by the Buyer, Anton Paar's warranty obligation is limited to the compliance with the Buyer's specifications and does in no event extend to material supplied by the Buyer.

- 10.7 Anton Paar accepts no warranty for the sale of used goods.
- 10.8 Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.

Any reference to “You” is a reference to the Buyer.

- 10.8 If the Buyer is a ‘consumer’ (for the purposes of the Australian Consumer Law) and any goods supplied to the Buyer by Anton Paar under these Terms are not goods which are ordinarily acquired for personal or domestic household use, then Anton Paar’s liability to the Buyer in connection with any breach of the consumer guarantees in respect of those goods is limited (at Anton Paar’s discretion) to:
- a. the replacement of the goods or the supply of equivalent goods;
 - b. the repair of the goods;
 - c. the payment of the cost of replacing the goods or of acquiring equivalent goods; or
 - d. the payment of the cost of having the goods repaired

11 Liability

- 11.1 To the extent permitted by law, Anton Paar shall be liable only if the damage in question is proved to be due to intentional acts or acts of gross negligence, within the limits of statutory provisions. Anton Paar shall not be liable for damage due to acts of ordinary negligence.
- 11.2 Anton Paar shall not be liable for and disclaims all warranty obligations for any damages or losses arising from the Buyer’s (or any third party’s) subsequent use or misuse of the products and/or services including, without limitation
- a. fair wear and tear;
 - b. abnormal working or operating conditions beyond those referred to in the product specification, including atmospheric discharges, excess voltage and chemical influences;
 - c. the Buyer’s (or any end user’s) negligence or willful misconduct, or that of its agents or employees, or any failure to follow Anton Paar’s instructions as to use of the products;
 - d. assembly, installation, modification, alteration, service or repair work not undertaken by Anton Paar or a representative authorised by Anton Paar in writing; and
 - e. compliance or non-compliance with licensing requirements.
- 11.3 Anton Paar’s liability for any and all claims, whether based on contract, tort, statute, indemnity or otherwise, arising out of or in connection with this agreement are limited in their aggregate total to the value of the respective order. Any claims exceeding this limitation of liability are expressly excluded.
- 11.4 In no event shall Anton Paar be liable to the Buyer for (i) any indirect, special, consequential, incidental or punitive loss or damage; or (ii) loss of data or other equipment or property; or (iii) economic loss or damage; or (iv) incurring of liability for loss or damage of any nature whatsoever suffered by third parties, including in each case incidental and punitive damages; or (v) any loss of actual or anticipated profit, interest, revenue, anticipated savings or business or damage to goodwill in connection with or arising out of an order.

11.5 Subject to the preceding subparagraphs of this clause 11 and the limitations of liability set out herein, any and all claims that may arise out of or in connection with an order shall, to the extent legally possible, be dealt with in accordance with the respective liability insurance coverage policy of the parties

12 Statute of limitations

12.1 To the extent permitted by law, the Buyer's right to redress for all claims against Anton Paar arising out of the Buyer's warranty obligations to a customer further to a resale of the products is excluded. Where the exclusion of the redress is prohibited by mandatorily applicable law, the right to redress is limited by the warranty period provided under clause 7.1.

12.2 All claims for breach of contract must be brought before the competent courts by the Buyer within six years from the date of the breach occurring, all other claims must be brought before the competent courts within such shorter period of limitation provided by law.

13 Force Majeure

13.1 Unforeseeable circumstances or circumstances beyond either party's control, including all cases of force majeure, may have a direct or indirect impact on delivery times. If this is the case, the delivery period shall be extended for the duration of such unforeseeable circumstances. These circumstances include for example, earthquakes, floods, fire, storm, natural disaster, armed conflicts, sanctions, embargoes and official interventions and prohibitions, delays in transport or customs clearance, damages in transit, energy shortage and raw material scarcity, labor disputes, default in performance by a major component supplier who is difficult to replace and any similar unforeseen event that renders performance commercially implausible.

14 Cancellation

14.1 Unless expressly agreed otherwise, you may only cancel a purchase order for the purchase of products, if the delivery of the products has been delayed due to our gross negligence and the reasonable grace period you set has expired. The cancellation shall be submitted by registered mail only.

14.2 Irrespective of our other rights, we may cancel, in whole or in part, an order for the purchase of products or without any liability to you, if a) for reasons attributable to you, the delivery of the products is rendered impossible or delayed despite setting a reasonable grace period; b) the delivery is or becomes unlawful (unlawfulness may include, for example any embargo, sanction or other international requirement related to foreign trade or customs); c) the delivery is delayed for more than six months due to reasons set out in clause 11.

14.3 If insolvency proceedings are instituted against any contracting party or an application for insolvency proceedings against that party is not granted for insufficiency of assets, the other party may withdraw from the contract without allowing a period of grace.

14.4 Other consequences of the cancellation are excluded.

16 Definition of Consumer

16.1 If you are a customer of Anton Paar's website and a consumer within the meaning of the Australian Consumer Law (ACL) set out in Schedule 2 of the Competition and Consumer Act 2010, the special conditions for consumers ("Special Conditions") apply to all of your purchases made on Anton Paar's website.

17 Information about the possibility of Alternative/Online Dispute Resolution

17.1 If you have a complaint about a good or service you have bought, instead of going to court, you can choose Alternative Dispute Resolution (ADR). The term ADR includes all the ways of resolving a complaint which do not involve going to court. Typically, consumers ask a neutral third party to act as an intermediary between them and the trader; this neutral third party is called an ADR entity. The ADR entity can then suggest or impose a solution, or simply bring the two together to discuss how to find a solution. 20 Language

21 Applicable law and dispute resolution

21.1 This Agreement, the use of this website and any order or purchase made through this website is governed by the law of Australia, without its conflict of laws provisions. The application of the UN Convention on Contracts for the International Sale of Goods is renounced.

21.2 A reference to a particular statute, statutory provision or subordinate legislation is a reference to it as it is in force in Australia from time to time taking into account any subordinate legislation for the time being in force made under it.

21.3 All disputes arising out of or in connection with the present Agreement, your visit to our website or any item purchased by you through our website, shall be subject to the exclusive jurisdiction of the competent courts of Sydney, Australia.

22 Miscellaneous

22.1 This Agreement constitutes the entire agreement and understanding between you and us and supersede any previous agreement (if any) relating to purchases made on our website. By making an online purchase order you confirm that you do not rely on any pre-contractual representations or statements.

22.2 Should individual provisions (or parts thereof) of this Agreement be invalid, unenforceable, the other provisions shall remain in force. The invalid, unenforceable or illegal provision (or part thereof) shall be replaced by a valid, enforceable and legal provision with whatever modification is necessary to give effect to the commercial intention of the replaced provision (or part thereof).

22.3 A variation of this Agreement is only valid if expressly agreed between the parties. No failure or delay to enforce any provision of this Agreement shall constitute a waiver thereof or of any other provision, unless we expressly waive our right to enforce such provision in writing.

22.4 A person who is not party to this Agreement shall not obtain any rights under this Agreement. Liability limitation(s) contained in clause 10 and the time limit for the assertion of claims also applies for the benefit of our employees, officers, agents, subcontractors and suppliers.

22.5 You must not without our prior written consent assign, transfer or charge rights or any part of them under this Agreement or subcontract any or all of your obligations under this Agreement.
