1 Scope

- 1.1. These General Terms of Promotion (GToP) apply to the Promotion organised by Anton Paar Malaysia Sdn Bhd.
- 1.2. By entering the Promotion, the participant expressly consents to these General Terms of Promotion and to the processing of the entrant's personal data for the purpose of promotion.
- 1.3. For the purposes of these GToP the promotion is a raffle of 100 MYR eWallet ("Free Gift") credits amongst the participants who have registered via the following webpage <https://www.anton-paar.com/my-en/tell-us-your-density-instrumentation/> ("Promotion").

2 Participation

- 2.1. All persons residing in Malaysia who have reached the age of 18 and actively use one of the stated instrumentations on the page listed (<https://www.anton-paar.com/my-en/tell-us-your-density-instrumentation/>) can participate in the Promotion. Employees of Anton Paar GmbH and its subsidiaries and affiliated companies as well as relatives of such employees and their relatives are excluded. Participation with forged identities or with identities of third parties is not permitted.
- 2.2. Participation is free of charge. Each participant can only take part in the Promotion once. The participant is responsible for the correctness of his/her information.
- 2.3. Participation is possible from March 21, 2022 until June 30, 2022. Once the winner is announced on July 08, 2022 the Promotion ends.

3 Gifts and Notification of Gifts

- 3.1. Any user filling out the form and being compliant with clause 2 "Participation" is eligible to participate and potentially win 100 MYR eWallet credits. Only one participant shall be winner of the Promotion. All users who filled in the contact form on <https://www.anton-paar.com/my-en/tell-us-your-density-instrumentation/> are put chronologically in an Excel list. Finally, the google number generator is used to generate a number (<https://www.google.com/search?q=google+random+number+generator>). The generated number reflects the random position of the winning user in the Excel rows.
- 3.2. The raffle draw will be made on July 08, 2022. Raffle winner will be notified via e-mail no later than 2 weeks after the draw date. The transfer of 100 MYR eWallet credits can be made only via Touch n GO eWallet (<https://www.touchngo.com.my>) or Grabpay (<https://www.grab.com/my/pay/>). The participant is responsible for possessing of the two eWallet options.

- 3.3. If Anton Paar does not receive written confirmation from a participant within a 14 days period, the claim to the Free Gift shall lapse. In this case, Anton Paar is entitled to determine a replacement participant be repeating the raffle draw that shall receive the Free Gift instead.
- 3.4. The prize won by the participant is not redeemable for cash and cannot be transferred or exchanged.
- 3.5. Anton Paar reserves the right to refuse the Free Gift offer or the Free Gift to any participant or a person.

4 Warranty, Liability and Indemnification

- 4.2. Anton Paar assumes no responsibility for lost, misplaced, destroyed or stolen Free Gifts once they are claimed. Any liability of Anton Paar with regard to the Free Gift and/or participation in the Promotion is excluded.
- 4.3. The participant indemnifies Anton Paar against all claims of third parties resulting from its participation in the Promotion.

5 Exclusion

- 5.1. In the event of a breach of these General Terms of Promotion, Anton Paar reserves the right to exclude persons from the Promotion.
- 5.2. Persons who use unauthorised aids or otherwise obtain advantages through manipulation are also excluded. In such cases, Free Gifts may also be subsequently withdrawn and reclaimed.
